

## A WORLD RAW POWERLIFTING FEDERATION (WRPF) EVENT

### Competitor Declaration

1. I, the undersigned, hereby declare that I am participating in this powerlifting competition of my own free will and at my own risk.
2. I acknowledge that this competition is an independent powerlifting event, organised by ANDRÁSI Üzletviteli Kft. which has been granted the right to organise this competition by the WRPF. The WRPF is an organisation independent of the Hungarian Powerlifting Federation (MERSZ) and the International Powerlifting Federation (IPF); accordingly, this competition is neither a MERSZ nor an IPF event.
3. I acknowledge that this competition is held in accordance with the rules and regulations of the WRPF and the World Equipped Powerlifting Federation (WEPF), and that the organisers hold the requisite licences from both organisations.
4. I declare that my physical condition permits my participation in this competition, and I acknowledge that powerlifting involves significant physical exertion and carries an inherent risk of injury.
5. I accept that my participation in this competition is entirely at my own risk, and I hereby waive any and all claims for damages against the organiser arising from or in connection with my participation in this competition, except to the extent that such liability cannot be excluded by applicable law.
6. I further acknowledge that photographs and video recordings may be taken of me during the competition, and that the organiser may use such material for the purposes of promoting the event.

The purpose of data processing is to document the competition, present the event, and promote the activities and events of the organizer on the powerlifter.hu website, as well as on the organizer's social media platforms and promotional materials. The scope of processed data includes the data subject's image and voice, as well as their name, competition number, category and results that may appear in connection with the recordings.

The legal basis for data processing is the data subject's voluntary and explicit consent. Consent may be withdrawn at any time by contacting info@powerlifter.hu; however, such withdrawal shall not affect the lawfulness of processing carried out prior to the

withdrawal. The recordings are stored by the data controller until the withdrawal of consent, or in the absence of such withdrawal, for a maximum period of 5 years.

Access to the recordings may be granted to the data controller and to communication, media and IT service providers engaged by the data controller. The data subject has the right to request access to, rectification or erasure of their personal data, restriction of processing, to object to processing, and to data portability, and may lodge a complaint with the Hungarian National Authority for Data Protection and Freedom of Information (NAIH).
